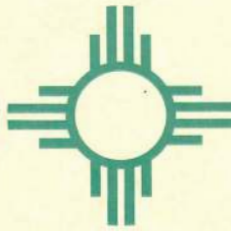

GENERAL ELECTION PROCLAMATION

Pursuant to NMSA 1978, § 1-8-13(B) (1969, as amended through 2021), I, Maggie Toulouse Oliver, Secretary of State, of the State of New Mexico, by virtue of the authority vested in me, do hereby conform the January 31st, 2022, General Election Proclamation to the intent of the law with respect to the offices for which each political party shall nominate candidates as follows:

House Bill 86, Chapter 56, was passed and signed into law during the 2022 legislative session creating new judgeships. The effective date of these new judgeships is July 1, 2022.

GENERAL ELECTION FILING DEADLINES:

Appointments to fill vacancies in the list of a party's nominees shall be made and filed with the proper filing officer using a form approved by the secretary of state by September 6, 2022, by 5:00 p.m., along with a declaration of candidacy subscribed and sworn by the selected nominee and the required form for candidates pursuant to the Campaign Reporting Act [Section 1-19-25 to 1-19-36 NMSA 1978].
