Ryan Williams Emergency Manager presented US Drought Monitor showing extreme drought conditions and said that there is not enough precipitation and none to be expected until after July 4, 2025. He stated that conditions are just too risky and that almost all counties in NM have full burn bans because Public safety is the #1 priority.

Sheriff Baker proposed that the Commission consider removing ground audible fireworks from the ordinance-stating that they don't pose a threat and would increase calls to the Sheriff's department.

Attorney Pato agreed and stated that there are a few fireworks permitted such as sparklers and ground fireworks as long as you have access to water.

Commission Vice-Chair Paxon MOVED to clarify Section 6 and add an amendment to say "arial" fireworks as presented. Commissioner Hopkins SECONDED the motion. Motion carried with Commissioners District 1-2-3 voting yes.

Commissioner Hopkins MOVED to adjourn the meeting. Commission Vice-Chair Paxon SECONDED the motion.
