(Any award of an exemption will be for the current tax year only and will not relieve the organization from the payment of previous years' taxes, interest and penalties.)

Pursuant to Section 7-38-17 NMSA 1978, exemption of non-governmental entities must be applied for, approved and claimed to be allowed. Once approved, reapplication is not necessary in subsequent tax years so long as the <u>use</u> of the property, <u>ownership</u>, <u>boundary lines</u> and <u>mission</u> of the organization remain without change. Complete and submit this application to the Sierra County Assessor's Office. <u>The official application submittal period is January 1, 2019 up to thirty (30) days following annual Notice of Value mailings.</u> Property will be presumed <u>NOT EXEMPT</u> and taxed accordingly <u>OUTSIDE</u> dates indicated. All new religious, charitable or educational organizations must follow this process for the exemption to be considered for Tax Year 2019.

IMPORTANT INFORMATION ON EXEMPTIONS:

- 1. It is the <u>USE</u> of the property BY QUALIFYING INCORPORATED NON-PROFIT/CHARITABLE/EDUCATIONAL ORGANIZATIONAL OWNER(S), not the declared objects and purposes of its owners which determines the right to exemption. The charitable or educational purpose of the property must be its <u>PRIMARY</u> use.
- 2. The IRS 501 C() designation for federal income tax exemption <u>has no applicability</u> to applicant organization's claim for property tax exemption in New Mexico. This applies primarily to sales tax & the deductibility of donations on income tax reports etc.
- 3. Please complete this application in its entirety. If necessary, use additional sheets to support your claim for exemption.
