County of Sierra

PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED BY
NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the County of Sierra and the New Mexico Department of Transportation have entered into a joint and coordinated effort in Cooperative Agreement.

WHEREAS, the total cost of the project will be (\$409,296.00) to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or (\$306,972.00)
and
- b. County of Sierra's proportional matching share shall be 25% or (\$102,324.00)

TOTAL PROJECT COST IS (\$409,296.00)

County of Sierra shall pay all costs, which exceed the total amount of (\$409,296.00).

Now therefore, be it resolved in official session that County of Sierra determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on December 31, 2027 and the County of Sierra incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW THEREFORE, BE IT RESOLVED by the County of Sierra to enter into Cooperative Agreement Control Number **HW2 L100682** with the New Mexico Department of Transportation for LGRF Project for year 2026/2027 for the re-chip seal, fog seal, pothole and shoulder repair, drainage improvements, engineering & project management, culvert, and road surface work on various County roads to improve surface conditions in B096 Caballo Estates W Grand Percha from NM 187 W approx. 0.5 mi, Greenhorn from NM 187 W approx. 0.5 mi, Navajo from W Grand Percha S approx. 0.2 mi, Granite from W Grand Percha S approx. 0.2 mi, Apache from W Grand Percha S approx. 0.2 mi, Pima from W Grand Percha S approx. 0.2 mi, Sioux from W Grand Percha S approx. 0.2 mi, B102 Trujillo Creek from NM 187 W approx. 1.8 mi, B034 Black from NM 187 E approx. 0.6 mi, B037 Arrey from NM 187 E approx. 0.5 mi, B038 W Wagoneer from NM 187 E approx. 1.2 mi, B039 Sugar Sand from B038 W Wagoneer N approx. 0.8 mi, within the control of the County of Sierra in Truth or Consequences, New Mexico.

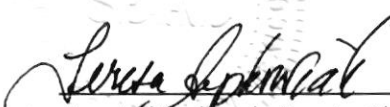
