To be deducted from the proper funds appropriated in the 2026-2027 FY Budget. August 18th, 2026

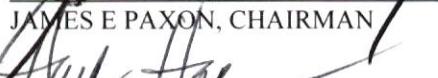


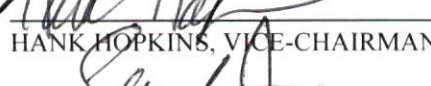
